PRE-ADMISSION

When you come to the hospital for your test or tour please come to the registration desk, located in the front lobby of Trios Women's and Children's Hospital, 900 S. Auburn, Kennewick.

The registration representative will have you complete the following:

- 1. Registration form for your future delivery. At this time, you will sign for your consent to be treated and complete any other payer required paper work that is needed for your stay.
- The registrar will assist you with financial arrangements for your stay, if needed, by contacting one of our financial counselors.

ADMISSION

OB Patients: If you believe you are in labor please go to Trios Women's and Children's Hospital located at 900 S. Auburn. (See map on back) There are no obstetric services at Trios Southridge Hospital.

Please come to the front lobby of the Woman's and Children's Hospital to the registration area located just inside the entrance of the facility. We are open 24 hours a day. The registration staff will check you in and direct you to the Family Birthing Center for services.

FINANCIAL RESPONSIBILITY

The OB Pre-Admission Registration form asks for financial information so that we may help you with any arrangements necessary to cover your services and stay with us.

If you are <u>covered by insurance</u>, please provide your insurance cards and identification when you check in or pre-register. If your insurance does not provide 100% coverage, you will need to discuss financial arrangements with a financial counselor.

If your service is <u>not covered by insurance</u>, the financial counselor will guide you on your payment options.

The following methods of payment are available:

- 1. Payment of the account in full within 30 days of the first statement with a 10% discount.
- If your financial situation does not allow you to pay within 30 days of the first statement, you will need to speak to a financial counselor for payment options and to set up payment arrangements. Call 509-221-5748



From Spokane

Heading south on Highway 395 to Pasco, take the Kennewick/Richland exit. Take Exit 12A to Kennewick. Then travel across the Blue Bridge and take the 2nd exit to W. Columbia Dr. The exit ends at a double round-about; continue on W. Columbia Dr. Travel east on W. Columbia Dr. and turn right on Washington St. Travel north on Washington St. Turn right on W. 8th Ave. Trios Women's & Children's Hospital will be on the left.

From Yakima

Heading southeast on Interstate 82, take Exit 113 to Highway 395. Travel on Highway 395 to W. 10th Ave. Turn right on W. 10th Ave. Travel east on W. 10th Ave., and turn left on S. Dayton St, then right on W. 8th Ave. Trios Women's & Children's Hospital will be on the right.

From Oregon

Heading north from Umatilla on Interstate 82, take Exit 113 to Highway 395. Travel on Highway 395 to W. 10th Ave. Turn right on W. 10th Ave. Travel east on W. 10th Ave., and turn left on S. Dayton St, then right on W. 8th Ave. Trios Women's & Children's Hospital will be on the right.

From Finley

Heading west on Highway 397 (Chemical Drive), turn left on 10th Ave. Travel west on 10th Ave. Turn right on Washington St., then left on W. 8th Ave. Trios Women's & Children's Hospital will be on the left.
