## Trios Health Reproductive Health Policy

### I. PURPOSE STATEMENT

To provide a guideline on which reproductive services are provided at Trios Health/Trios Medical Group.

### II. POLICY and/or PROCEDURE STATEMENT

- A. Trios Health/Trios Medical Group provides a service for the care of patients who need Obstetrical and Gynecological care. All patients will receive care based upon their individual needs.
- B. Services provided include the following, but are not limited to;
  1. Routine and high-risk obstetrical care
  2. In-patient obstetrical care
  3. Vaginal birth
  4. Cesarean birth
  5. Hormone replacement therapy
  6. Vaginal reparative surgery
  7. Incontinence procedures
  8. Laparoscopic surgery
  9. General and adolescent gynecological care
  10. Natural and traditional menopausal care
  11. Annual exams
  12. Preconception counseling
  13. Contraception counseling
  14. Infertility
  15. Management of Premenstrual Syndrome (PMS) and Premenstrual Dysphoric Disorder (MPDD)
  16. Sexually Transmitted Disease (STD) screening and treatment
  17. BRCA genetic testing (BRCA1 and BRCA2 assesses if a woman has an increased risk of developing breast and ovarian cancer)
  18. COLARIS genetic testing (assesses a woman's risk of developing hereditary uterine cancer)

19. Termination of pregnancy

- C. As per RCW 9.02.150, Trios Health does not mandate that any provider or staff member participate in the termination of a pregnancy. Only those providers and staff who are willing and desire to participate should do so. If an employee does not want to participate in the act, he or she must follow the process outlined in the Trios Health Employee Policies.
